

## Declaration of the “Regional Meeting of National Committees on International Humanitarian Law and Other Similar Entities of the Americas”

February 5<sup>th</sup>, 2021

The delegations<sup>1</sup> participating at the “*Regional Meeting of National Committees on International Humanitarian Law and Other Similar Entities of the Americas*”,

*reaffirming* that International Humanitarian Law (IHL) remains as valid today as ever before in international and non-international armed conflicts, even as contemporary warfare presents new developments and challenges;

*recalling* that the obligation, under any circumstances, to respect and ensure respect<sup>2</sup> for international humanitarian law, applies to all states parties to the four universally recognized Geneva Conventions of 1949 and to the states parties to one or more of the three protocols additional thereto;

*highlighting* the fundamental role of National IHL Committees and other similar entities for contributing with the dissemination and implementation of IHL in their respective States;

*reaffirming* the importance for National IHL Committees and other similar entities to strengthen their communication and the necessity of sharing experiences and building the adequate mechanisms to foster cooperation between them;

*emphasizing* the vital importance of building on existing efforts to achieve more effective implementation and dissemination of IHL and of demonstrating the benefits of IHL for all parties to armed conflict and for the protection of all victims of armed conflict;

*recognizing* the important role of the International Committee of the Red Cross (ICRC) and the International Red Cross and Red Crescent Movement as a whole, for the support they provide to and with States in the dissemination and implementation of IHL, particularly through their support to the National IHL Committees and other similar entities;

*convinced* that the measures recommended below provide a useful road map for effective implementation of IHL at the national level;

1. **Confirm** the importance of supporting the work of National IHL Committees and other similar entities, and identify measures to strengthen their organization and functioning;
2. **Recognize** the efforts and initiatives of National IHL Committees and other similar entities to disseminate, promote and respect IHL;

3. **Firmly encourage** the National IHL Committees and similar entities to intensify the IHL dissemination work, acting in a proactive manner among organizations committed to such objectives, such as central and local governmental authorities, legislative and judicial authorities, the military, the security forces, professionals, academia and civil society members;
4. **Undertake** to intensively work to strengthen cooperation between National IHL Committees and similar entities on the international, regional and cross-regional levels, particularly through assistance and active participation in the universal, regional and other periodic meetings of such entities, and through the new digital community for National IHL Committees and other similar entities, created on the basis of the recommendations made by the participants at the universal meeting that took place in 2016;
5. **Agree** that for the purposes indicated in the previous paragraph, it is necessary to implement the appropriate mechanisms to optimize the necessary actions in order to make effective the cooperation schemes between the National IHL Committees and similar entities considering the emerging and critical situations that require specific collaboration, and in this sense, encourage the ICRC to continue playing a role as facilitator of these exchanges;
6. **Encourage** the exchange of experiences and good practices related to the work of National IHL Committees and other similar entities facilitating their operation and encourage States that have not yet done so to consider establishing such an entity;
7. **Welcome** the work of the ICRC and request that it keeps on providing its collaboration and support so that States can continue to carry out activities that make it possible to achieve the objectives of organic strengthening and development of the National IHL Committees and similar entities;
8. **Invite** its respective States to ratify, when relevant, IHL treaties, including the Additional Protocols to the Geneva Conventions<sup>3</sup>;
9. **Encourage** their respective States to adopt necessary legislative, administrative and practical measures at the domestic level to implement IHL, promoting the participation of civil societies organizations when it is convenient and invites States to carry out, with the support of their National IHL Committees and other similar entities and the corresponding National Red Cross Societies, where possible, an analysis of the areas that require implementation at a national level;<sup>4</sup>
10. **Make an appeal** to continue promoting the work of the National IHL Committees and similar entities within the framework of the next International Conference of the Red Cross and Red Crescent, in following up on commitments adopted by their respective States in these meetings;

11. **Recognize** the importance of a continued conversation about how IHL applies to cyber operations as well as the challenges regarding its implementation in their respective States;
12. **Thank** the illustrious Government of the Republic of Ecuador and the ICRC for the valuable support provided for the organization and the development of the “*Regional Meeting of National International Humanitarian Law Committees and other similar entities of the Americas*”. Also recognize the technological work and logistical support provided by *Universidad Técnica Particular de Loja* for conducting this meeting;
13. **Agree** to reconvene in two years and encourage National IHL Committees and similar entities to come forward and offer to host the next meeting. To that end, the ICRC is requested to receive nominations for host countries for the next “*Regional Meeting of National International Humanitarian Law Committees and other similar entities of the Americas*” scheduled for 2023 and will notify the results of the designation to the remaining Committees.
