## PROMOTER AND GUARDIAN OF INTERNATIONAL HUMANITARIAN LAW

The ICRC was founded in 1863 on the basis of Henry Dunant's ideas. From the beginning, we asserted our role as promoter and guardian of international humanitarian law. Until then, wounded soldiers had been left untended on the battlefield; the ICRC set out to improve the fate of victims of war. Over the following decades, we were the driving force behind the adoption of the four Geneva Conventions and other international agreements, which

stepped up protection for the wounded and sick, prisoners of war and civilians, and banned certain weapons.

## THE LARGEST HUMANITARIAN MOVEMENT IN THE WORLD

As part of our mandate under the Geneva Conventions, the ICRC works alongside the 190 National Red Cross and Red Crescent Societies to alleviate suffering and safeguard human life and dignity, particularly during armed conflicts and other violence.

## **FAMILY MATTERS RESTORING FAMILY LINKS**

Since the founding of the ICRC more than 150 years ago, we have helped countless people find a missing child, parent, sibling or spouse. We offer vital support to families, wherever they may be — in a displacement camp, in prison or at home. This often includes conveying messages between separated family members, and we have successfully reunited thousands of families over the years.

## THE KIDNAPPING OF FOUR-YEAR-OLD EMMANUEL: "PAPA! PAPA!"

"It was 7pm and we were just settling down around the fire," says Rosa, recalling the night of 28 August 2016. "Suddenly, we hear our neighbour Federiko scream, 'My kids, my kids!' This man – probably a livestock rustler – appears out of nowhere and punches my husband. My son Emmanuel starts crying and shouts, 'Papa! Papa!' This guy then picks up my son and runs off with him." Rosa tells us she was convinced she would never see him again.

Thankfully, the story doesn't end there. Eighteen months later, ICRC colleagues received reports of a young boy crying for his family, in another part of the country. After making some checks, we were able to confirm that this was Rosa's long-lost son and help bring him home.

"Reuniting Emmanuel with his family was both moving and unsettling," says ICRC delegate Céline Croon. "Rosa and her husband were over the moon, but Emmanuel had forgotten his mother tongue and was very wary." Their neighbour Federiko was also reunited with his daughter Monika (7) and son Victor (13) on the same day.

"Bringing separated family members back together takes time and hard work," says Céline. "You have to check everyone's identity, gain official authorizations, sort out all the logistics... But hearing families say that their hearts are finally at peace makes it all worth it!"



78 579 detainees were visited.

**3,600** people with disabilities received physical rehabilitation services.

**58,400** people who'd fled their homes and members of the communities who'd accepted them benefited from better access to clean water.

## HOW IMPORTANT ARE BEQUESTS FOR THE ICRC'S ACTIVITIES?

Very. Most people do not specify how they wish their bequest to be spent. This mark of trust means we have funds available to provide emergency aid immediately.

## CAN I LEAVE A GIFT IN MY WILL FOR A SPECIFIC COUNTRY OR CAUSE?

If you would like your legacy to be used in a particular country, like Syria, or for a particular group of people, such as children, please get in touch so we can discuss your wishes. It is possible that our operations in a specific country will come to an end in the future. It is also easier for us to manage a more general request, such as helping to reconnect families, than one marked specifically for children. Greater flexibility means we can decide how best to use funding at the time.

## IS THERE A MINIMUM GIFT AMOUNT WHEN INCLUDING THE ICRC IN MY WILL?

The act of giving is a meaningful gesture, whatever the amount involved. When you show your support for the ICRC, you are helping to improve the lives of victims of armed conflict and you are giving them a future beyond war.

Every gift is important to the people we help, however large or small. Every gift helps to save lives.





## WHAT CAN YOU BEQUEATH TO THE ICRC?

In your will, you can bequeath any kind of asset, such as:

- **Money**: This is what most people choose to bequeath.
- Gifts in kind: Real estate, jewels, works of art, furniture, collections, etc.
- **Securities**: Shares, bonds, etc.
- Other assets: Patents, royalties, etc.

#### TAX EXEMPTION

The ICRC is exempt from paying inheritance tax on bequests in most Swiss cantons. This is also the case in Germany, France and the United States. To find out about other countries, or for any further information, please do not hesitate to contact us.

## WHAT KIND OF BEQUEST SHOULD YOU CHOOSE?

- ✓ **Specific bequest**: You bequeath one or more items. It is important to mention the specific item(s) bequeathed to the ICRC.
- ✓ **Residuary bequest**: You leave to the ICRC what remains of your entire estate after other specific bequests and costs have been paid.
- ✓ **Reversionary bequest**: You provide for a share of your estate to go to the ICRC if the heir named in your will passes away before inheriting, after other specific bequests and costs have been paid.

#### WHY MAKE A WILL?

In order to make a bequest, you must make a will stipulating your final wishes. You can revoke or change it at any time.

## WHAT KIND OF WILL SHOULD YOU CHOOSE?

- Holographic will: Written entirely in your own hand, this is the simplest kind of will. If you opt for a holographic will, you should consult a professional, such as a notary, lawyer, bank official or financial consultant, to ensure that your will clearly reflects your wishes and complies with the law, especially regarding the entitlements of family members.
- Notarial will: Drawn up in the presence of two witnesses and before a notary or any other person empowered to do so, this document guarantees that your will complies with the law

## **HOW TO WRITE YOUR OWN WILL**

- ✓ Write your will by hand.
- ✓ Write your full name, date of birth and address, as well as the names and addresses of people and organizations to whom you are leaving bequests. For the ICRC, please put:

- 3. I leave the remainder of my assets, up to two-thirds (2/3), to my partner, [full name], born on [day, month, year] and residing at [address].

#### **HOW DO I WRITE MY WILL?**

Depending on your last country of residence, the law might provide for other formal requirements for a will to be valid; we recommend you check with a local adviser.

#### WHAT CAN I BEQUEATH TO THE ICRC?

#### WILL THE ICRC HAVE TO PAY INHERITANCE TAX?
