

JORDAN MAIN FACTS & FIGURES FOR THE FIRST HALF OF THE YEAR FROM JANUARY TO JUNE 2024





PROTECTING THE MOST VULNERABLE/ INCREASING RESILIENCE

- **16,900** people in Sabha area in North Badia have gained access to a more reliable water supply due to the rehabilitation of Sabha Al Balad Pumping Station completed in early January 2024.
- Inauguration of Hofa Workshop and Training Center in Irbid Governorate. The center will offer specialized workshops in mechanical, and pipeline works, instrumentation, chlorine handling, and electrical panels for Yarmouk Water Company staff.



SUPPORTING FAMILIES OF MISSING PERSONS (AS A RESULT OF THE CONFLICT IN SYRIA)

- **240** family situation assessments were conducted with families of missing persons (including those in Azraq refugee camp) to identify their needs.
- **365** people benefited from the Micro Economic Initiative grants to start income-generating activities as part of the families of missing persons accompaniment programme.
- **276** people received unconditional cash for startups to meet their health, and other essential basic needs as part of the families of missing persons accompaniment program.
- **62** people were referred to external service providers to address their multidisciplinary needs (legal, protection, health, mental health, and psychosocial support).
- **79** Mental Health and Psychosocial Support (MHPSS) sessions took place in Amman, Mafraq, Irbid, and Zarqa for **108** families of missing persons.
- **955** families were contacted either by phone calls or home visits to exchange news about their missing relatives.
- **434** households in Azraq and Zaatari refugee camps (benefiting **758** refugees) were visited during the door-to-door outreach to identify missing cases.
- **125** new missing cases were collected from families of missing persons.
- **1,434** calls were facilitated in cooperation with the Jordan Red Crescent Society (JRCS) for refugees residing in both Azraq and Zaatari refugee camps.
- **14** messages (Safe & Well Salamat/Red Cross messages) were exchanged between detainees abroad and their families.



ENSURING RESPECT FOR THE DIGNITY OF PEOPLE DEPRIVED OF THEIR LIBERTY

- 171 detainees in 5 places of detention were monitored individually by the ICRC.
- 101 detainees were registered in 10 visits.
- 44 detained foreigners were notified to their respective embassies, UNHCR and UNRWA.
- **82** Red Cross Messages (RCMs) were collected from and **15** distributed to detainees.
- **30** health and non-health staff working in detention facilities attended one-day workshop organized by the ICRC to disseminate the recently ratified National Protocol of Management of Hunger Strike in Correction and Rehabilitation Centers (CRC). *Since 2018 the ICRC has been at the forefront of discussions with penitentiary healthcare authorities in Jordan regarding the management of detainees on hunger striker clinically and ethically.*

PROMOTING INTERNATIONAL HUMANITARIAN LAW (IHL) AND INTERNATIONAL HUMANITARIAN RIGHTS LAW

- To commemorate the Geneva Conventions 75 anniversary, a photo exhibition "Dialogues on Humanity" was launched in June in collaboration with the Swiss Embassy followed by film screening titled "Prisoners of Fate" shedding light on the struggle of refugees.
- **46** students from the Judicial Institute of Jordan (JIJ) attended a dissemination on International Humanitarian Law (IHL).
- **25** participants attended the experts meeting organized with the Jordanian National Commission for the International Humanitarian Law (NCIHL) to discuss the applicability of IHL on cyber warfare.
- **25** participants attended the experts' meeting organized with NCIHL to discuss the challenges of Urban Warfare.
- **75** law school students received IHL disseminations.
- **Two** IHL clinics are currently working on research topics related to the legal status of missing persons and the compatibility of Jordanian legislation with the Convention on Enforced Disappearance.
- **491** officers from the Public Security Directorate, including **76** females, participated in **27** events or workshops.
- Supported the preparation and implementation of the Eager Lion military exercise conducted by the Jordan Armed Forces (JAF) with the participation of **16** countries.
- 20 Border Guards received a dissemination session on International Humanitarian Law (IHL).
- **45** staff officers attended **2** lectures held at the Peace Operations Training Center (POTC), including a dissemination session and a Training of Trainers (ToT) on emerging technologies.
- **2** lectures were given during the Jordan Armed Forces (JAF) regional workshop on Peace and Security, held at the POTC.



PARTNERSHIP WITH THE JORDAN RED CRESCENT SOCIETY (JRCS)

• **125** Red Crescent Action Teams (RCAT) volunteers deployed at **4** Marathons with first aid provided for **254** medical cases.



THE LOGISTICS SUPPORT CENTRE (LSC)

- **3,800** order lines of medical/prosthetics supplies, essential relief goods and food, with net a value of **11.2** MLN CHF were shipped from Jordan to **13** destinations mainly Gaza, Yemen, Syria, Iraq and Lebanon.
- **5.9** MLN CHF net value of orders delivered to Gaza: medical/prosthetics supplies, a complete field hospital, essential relief goods and food were delivered from Amman Logistics Support Centre.
