# **FACTS & FIGURES**



In 2024, the humanitarian landscape continued to be shaped by crises, including armed conflicts and violence, affecting some of the most vulnerable populations. East-Africa was no exception. Despite global humanitarian funding constraints, the International Committee of the Red Cross (ICRC) maintained its commitment to neutral, impartial and independent humanitarian action.


One example is our support to families separated as they escape conflict and other situations of violence in the Great Lakes Region, crossing borders, including into Rwanda. In partnership with the Rwanda Red Cross Society (RRCS) and other components of the International Red Cross and Red Crescent Movement, we help reconnect and reunify family members, ensuring their right to remain connected with their loved ones.

We could not do this work without strong partners within the Red Cross Movement. As part of our collaboration with the RRCS, we aim to strengthen its capacity to provide quality humanitarian services, as a first responder in times of crises.

International humanitarian law (IHL) is at the core of ICRC's mandate and mission. In Rwanda as well, the ICRC continued to promote awareness, understanding, and respect for IHL, working closely with national authorities, military and law enforcement institutions, diplomatic and academic circles, as well as media. The aim is to ensure the safety and dignity of people affected by armed conflicts. To this end, we supported Rwanda's efforts to integrate and implement both IHL and International Human Rights Law (IHRL) into national legal framework, and to disseminate IHL in pre-deployment sessions with troops training for their deployment abroad.

#### AWARENESS OF INTERNATIONAL HUMANITARIAN LAW







**37** National authorities' representatives, key influential humanitarian actors, members of the Justice sector and diplomatic community participated in different sessions on ICRC mandate and its priorities in Rwanda and the region and in IHL related events.



**589** Law students from **5** Rwandan Schools of Law participated in IHL related national and regional Moot Court Competitions, public lectures and Youth Dialogues (IHL dialogue conducted jointly with RRCS).



**1500** IHL related books were distributed to law students as well as security and law enforcement organs and other key stakeholders.




**20** Lecturers and Rwanda Red Cross Society staff attended IHL promotion events by the ICRC, including a workshop on "IHL and New Technologies".



**40** Journalists, influencers, and Officers in charge of public relations in key national institutions (such as Ministry of Defense, Ministry of Foreign Affairs, Rwanda Investigation Bureau, Rwanda Correctional Service), attended an awareness session on ICRC mandate and IHL.

120,010 People were reached and sensitized on IHL through online platforms and radio and TV talks.

#### RECONNECTING FAMILIES SEPARATED BY CONFLICT



26,984 Phone calls were made to help refugees and asylum seekers reconnect with separated family members.



17,470 Phone charges were provided for refugees and asylum seekers in transit centers, to help them contact their families.



2,954 Red Cross Messages containing brief family news were exchanged between separated family members in Rwanda and abroad.



153 Unaccompanied/separated children and vulnerable adults were reunited with their families in Rwanda.



229 Missing persons were found, and contact was reestablished with their families.

191 Families received cash assistance to support the reintegration process of their reunified family members.

### **WORKING WITH RWANDA RED CROSS SOCIETY (RRCS)**





**300** RRCS volunteers acquired insurance as part of safer access and safety measures during humanitarian operations.



3 Refresher sessions conducted by RRCS staff to volunteers and stakeholders for safer access during humanitarian operations.





113 RRCS volunteers were trained in responding to the protection of family links needs in emergencies.

**2** Sets of Virtual Reality equipment donated to RRCS to support the IHL Dissemination programme using digital technologies.



1 RRCS Senior Leadership member supported to attend the 2024 Red Cross and Red Crescent (RCRC) Council of Delegates and the 34th International Conference of the RCRC Movement in Geneva, Switzerland.


