FACTS AND FIGURES 2016 Cotabato Office



The International Committee of the Red Cross (ICRC) first established a permanent presence in Mindanao in 1986 by opening a sub-delegation in Davao City. In 2008, the ICRC opened an office in Cotabato City due to the humanitarian needs in this area. At present, the ICRC Cotabato office covers Maguindanao, Sarangani, Sultan Kudarat, North Cotabato, Cotabato City, General Santos City, Lanao del Sur and Lanao del Norte.

Assistance to conflict-affected communities

12,560 displaced people received food aid

845 people received cash assistance for livelihood restoration or shelter repair

2,205 people participated in cash-for-work programs

22,500 displaced people in Datu Salibo, Maguindanao, benefitted from the construction of 12 toilets and nine hand pumps with slow sand filter

16,619 people benefitted from the construction of 14 hand pumps with slow sand filters in Datu Saudi Ampatuan, Maguindanao

Detainee visits

ICRC staff visited 10 detention facilities in Central Mindanao, with a total population of **3,444 detainees**, to monitor their treatment and living conditions

We also provided medical treatment to people deprived of liberty

Raising IHL awareness

Around **1,081 police and military officers**, as well as a total of around **362 members** of non-state armed groups participated in discussions or workshops on international humanitarian law (IHL) and humanitarian principles in armed conflict

Over **130 Muslim scholars, dignitaries and representatives** from non-state armed groups in Marawi and Cotabato cities participated in seminars on IHL and Islamic law and jurisprudence

555 wounded patients benefitted from medical supplies in **11 hospitals** and **26 first aid posts** during clashes and situations of violence



47 patients with conflict wounds were assisted with medical expenses not covered by Philhealth and transportation costs

Three public hospitals were provided medical supplies and equipment every three months for their emergency rooms



312 people, including **258 health staff** from rural health units, received training on first aid and basic life support



36 amputee victims of the conflict were provided with prosthesis and physical rehabilitation through Davao Jubilee Foundation



2,500 families benefitted from essential medicines provided by four mobile health units in Maguindanao
