Within the framework of the 2016 Pictet Competition, this panel takes stock of the current state of the reflection on effective military training in IHL and the ICRC's efforts in the field of dissemination. An insight into current efforts in academia will also be given as an example of one of the most practical and developed strategies adopted to generate respect for the law. The panelists will eventually address topical challenges in the field of dissemination and integration of IHL with the aim of further improving current efforts.

Editor in Chief of the IRRC and Head of the ICRC Law and Policy Forum

Vincent Bernard became Editor-in-Chief of the International Review of the Red Cross in October 2010. A graduate of Strasburg's Political Sciences Institute, he holds a Masters degree in political sciences, an LL.M in international law (Law faculty in Strasburg and King's College London) and a D.E.S. in international relations from the Geneva Graduate Institute of International Studies.
